The Secretary's Report was reviewed. Sue Karn noted the following correction: Sue will be announcing at the Novice show, not Craig, as it is a non-paying position. Karen moved to approve with correction, seconded by Sue, motion carried.

The Treasurer's Report Profit & Loss statement was presented & reviewed. Balances:

Open \$25,409.89 Youth \$8,676.76 Futurity \$2553.79 Amateur \$ N/A Keely is to get a list of those that owe for advertising to Katie. She will then send out invoices .The bill for the directory is \$1800. Doreen moved to pay the printer & approve the Treasurer's Report. Seconded by Darren. Motion carried subject to audit.

## **National Directors Report**

**Connie Armstrong:** Four 50" TVs have been purchased. Sponsors were found for three TVs. Connie & Steve donated money for the 4<sup>th</sup>. They will be used this year or kept for future years if need be.

**John Hovde:** My Subcommittee has yet to meet to discuss: Updating the RHB Application, Different venue for Ranch Heritage Challenge Finals 2021, Young Horse Development Presentation, Ranching Heritage Breeder of the Year nomination process & RHB Survey Results(AQHA President Stan Weaver)

DENIED: Amend Rule SHW417.9 To recommend sitting the regular trot and lope. DENIED: Amend Rule SHW416.1 Ranch Riding. Changing the age from 3 years to 2 years and older.

APPROVED: Amend Rule SHW552.3 Divisions. The Cowboy division will offer 2 different qualifications:

1. Cowboy with no earnings cap &

Items we have covered so far:

2. Limited Cowboy with a max of \$15,000 in earnings (combined earnings last 3 years in all associations)

All Cowboy classes will compete the full VRH/RHC Ranch Cow work ans will not compete in the VRH/RHC Limited cow work for Amateur/Youth divisions. DENIED: Amend Rule SHW563.1 VHR COW WORK: This proposal boiled down to making horn catches legal. In other words, with horned cattle, the cow would not have to Look Through the Loop. This rule change would allow show committees to hire horned

cattle for the working events, a very dangerous situation.

DENIED: Discuss adding a Ranch Pleasure Class as a stand alone class from VRH. We do not argue against a rail pleasure class but to protect the integrity of the Ranch Horse we ask that it be called something other than Ranch Pleasure.

APPROVED: Amend Rule SHW Ranch Riding: Add Divisions 13 & under and 14-18 Youth and Level1 Select Amateur.

We also elected Jecca Ostrander as our Committee Chair.

**Scott Flach:** An abbreviated Youth meeting was held covering the convention. Bob & Jesse were sent the information. There were changes to the hardship forms and affiliate change. The forms are posted on the AQHA website. Jesse will also post on the Youth FB page. Discussion was held on the Scholarship for 2020(1 for ND) & YES conference.

## **Amateur Report:**

Ashley Everson said she is waiting on the show schedule. Sherri is having trouble accessing the Amateur account. Mindi is no longer on the account. Katie has contacted Bremer bank & they have sent the necessary documentation to Sherri.

## Youth Report:

Jesse Reported that Youth World Cup was canceled. AQHA is still planning on holding the YES Seminar & the Youth World Show. The AQHA Youth World Show change of affiliation has been streamlined. She has sent the form to Keely to post on the website. Jesse will also post them to the Youth Face book Page.

Letters of Intent are due April 30<sup>th</sup> if they plan to attend. Qualifying points have been waived for 2020, other requirements are still in place. Affiliates are not limited in the number attending. Ownership rules remain the same. No manipulation will be allowed. AQHA will still use qualifying points for records.

YWS offers an online entry system this year. Youth enter and pay entries themselves. AQHA will send Jesse a list to help her keep track.

Youth Performance Halter must have a qualifying ROM in a performance class in order to show in Performance Halter at the World Show. The 10 Point performance class has been waived.

Wrangler Aspire Award Scholarship (\$1000) applications are due May 1st.

YES Conference will be held June 29-July 1st. Forms are due May 15th.

National Officer Application is due May 15<sup>th</sup>.

Jesse has been having difficulty getting responses from the youth on their NDQHYA Face book page. Robin will make a list of Youth members & their email addresses & send it to Jesse. Most likely it will be a parent's email address.
